CONSIGNMENT AGREEMENT

Thank you for choosing Sell Your Sole Consignment Boutique, LLC as your partner in consigning. We are so pleased to have you in our community! Here is how our consignment program works:

When you bring your items in, we will carefully select items based on their condition, style, desirability of brand, and season. Please understand that sometimes there may be items that we will not be able to sell on your behalf.

We price each item based on brand, market value, condition and customer demand. Items are typically discounted every 30 days to facilitate their sale. The discount amount is at the sole discretion of Sell Your Sole.

The consigner will receive 50% of the selling price, or 55% in store credit. Premium Luxury items from specific designers: Tom Ford, Louis Vuitton, Chanel, Alexander McQueen, Givenchy, Celine, Balenciaga, Hermès, Saint Laurent & Rick Owens are eligible to receive a 70/30 split (70% to consigner & 30% to Sell Your Sole). Item selection and split rate is at the discretion of Sell Your Sole, and is based upon condition of the item and consumer demand. Shoes, sunglasses and basics are NOT eligible for a 70/30 split. Authentication documentation is required for luxury designer bags & watches. If you do not have it, we will have the item(s) authenticated by a 3rd party. The \$20 charge for authentication is the responsibility of the consignor (*you*).

The consignment period is 3 months and a \$5.00 fee will be charged per item, if you decide to retrieve your items before the end of the consignment period. Consignors are paid at the beginning of each month for items sold the previous month. Consigner checks are printed and mailed to the client at the address provided on this agreement. Sell Your Sole is not responsible for address updates on our client's behalf, and a \$30.00 stop payment fee will be deducted from your earnings if your check must be reissued.

Your items will be displayed for three months, and at the discretion of Sell Your Sole Consignment Boutique. Sell Your Sole Consignment Boutique, LLC has the right to terminate the consignment agreement at any time.

It is the consigners responsibility to remember their contract end date and arrange to claim their unsold items. Consigners will have a 3-day grace period to claim unsold items after the contract end date. Unclaimed items will be moved to the clearance rack for a period of 30 days, after which they become property of Sell Your Sole Consignment Boutique, LLC.

We will take exceptional care of the items you consign; however, merchandise is left at your own risk. Sell Your Sole Consignment Boutique, LLC is not responsible for loss or damage to any item for any reason, including theft or fire.
